- **Payment:-** Payment shall ordinarily be made after complete delivery of materials as per our order within 15 days from the date of submission of bills.
- **Delivery Period:-** All materials should have been supplied within 15 days from the date of the receipt of order.
- Only Manufacturer or Authorized Dealers can participate. The certificate of company regarding authorized dealership is to be enclosed along with the submission.
- In case, there is any increase or decrease in price list, the supplier is bound to produce the revised price list and shall be effective for the future supply order.
- Any terms & conditions of your offer repugnant to or inconsistent with the terms & conditions mentioned here shall be void and of no force & effects.
- **The University** reserves the right to terminate the rate contract at any time without assigning any reason thereof.
- The University reserves the right to accept or reject all or any tender without assigning any reason whatsoever.
- **Terms of delivery:** F.O.R. Door delivery at our concerned department of the University.
- Once the contract is issued, the orders for supply of Chemicals, Glassware, Plasticware & Miscellaneous will be issued as and when required by our concerned departments.
- All disputes are subject to Ahmedabad-Gujarat Jurisdiction.
- All the materials /Items supplied under the contracted shall have to be in conformity with all relevant ISI Standards. In the absence of the ISI standards, it is to be in conformity with the acceptable industries standards.
- The offer is valid for acceptance of PDEU for 120 Days for the date of opening of Tender.
- The offers are invited from manufacturers, authorized dealers, authorized suppliers, authorized stockiest for supply of chemicals.
