M. Tech. 2016 Admission Policy and Procedure **(For Nuclear Engg/ Energy Systems & Technology (Focused on Solar Energy/** **Chemical Engg.)**

1. Following shall be the schedule for the Admission Process:-

2. Eligibility Criteria: Min. aggregate 60% or CPI/CGPA of 6.5 in 10 point scale in the qualifying degree in respective discipline as mentioned hereunder. *Student has to comply with the criteria of required CPI/CGPA/percentage on the basis of aggregate of all the semesters as per the norms of this University only.*

NOTE:

1. The students expecting their qualifying degree results by **31st August 2016** can also apply.
2. 50% seats are earmarked for the candidates having Valid and Qualified GATE score.

Eligibility Criteria for respective branch:

(i) M. Tech. (Nuclear Engineering):

B.E./B. Tech. or equivalent in Mechanical/Electrical/Electronics/ Instrumentation & Control/Chemical / Civil / Metallurgical / Production/Industrial Engineering OR M.Sc. in Electronics/Physics/Nuclear Physics; with minimum 60% or CPI/CGPA of 6.5 on a 10 point scale as an aggregate of all the semesters.

(ii) M. Tech. (Energy Systems & Technology (Focused on Solar Energy)):

B.E. /B. Tech. or equivalent in Electronics/ Electrical/ Instrumentation & Control/Mech./ Semiconductor Technology/ Energy Science & Engg. OR M. Sc. or equivalent degree in Physics/Applied Physics/ Electronics/ Optoelectronics; with minimum 60% or CPI/CGPA of 6.5 on a 10 point scale as an aggregate of all the semesters.

(iii) M. Tech. (Chemical Engg.):

B.E./B.Tech. or equivalent in Chemical Engg./ Chemical Technology with minimum 60% or CPI/CGPA of 6.5 on a 10 point scale as an aggregate of all the semesters.

Every eligible candidate has to apply On Line through the University web site www.pdpu.ac.in

Fee for a single branch Application: Rs. 1500/- (Non Refundable)

Student can apply for maximum of three branches subject to the eligibility.

3. Admission Process:

(A) Phase - I (For the only candidates having qualified and valid GATE score):

Admission will be offered to the candidates on merit based on the GATE score. The candidates will have to confirm their admission upon paying the fees as per the schedule.

The seats remaining vacant upon completing admissions of Phase I will be transferred to the seats for Phase II admissions.

The candidates who are not offered the admission during Phase I, their application will be considered for the Phase II admission process and they will have to appear in all the components of the Phase II Admission Process mentioned in point No. 3(B).

It is mandatory for all GATE Qualified candidates to upload the GATE Score Card as a part of Online application process.

To break the tie between students for similar GATE score following criteria will be considered for deciding merit order in following sequence namely:

1. All India rank for GATE 2015 & 2016.
2. Marks out of 100 in GATE score card.
3. Aggregate marks/CPI of B.Tech. Degree.

(B) Phase-II (for GATE/Non GATE candidates):

The Phase-II admission process is meant for the candidates not having the valid and qualified GATE score, and also for the candidates having the GATE score but not offered the admission during Phase-I; as mentioned hereunder:

The verification of the testimonials will be held from 9.30 am to 10.30 am on the day of Written Aptitude Test in block D of the University Campus. At that time, the candidate is required to produce a set of the self-attested photocopies of all the relevant testimonials along with the originals.

A Written Aptitude Test (WAT) will be conducted in Block-C of the University campus from 11 AM to 1 PM. On the same day from 2 pm the personal interview will start. The interview process may continue even on the next day.

50% weightage of the score obtained in the Written Aptitude Test-WAT and 50% weightage of the score obtained in the Personal Interview-PI will be considered to prepare the merit list for admission.

The syllabus of the WAT for the respective branches of M. Tech. will be as mentioned on the University web site.

4. Fee Structure:

The candidates who have been offered the admission shall have to pay the fees as shown hereunder:

5. Hostel and Mess Facilities:

A candidate who has been offered admission to PDPU and is keen to avail the Hostel and /or Mess Facilities should report at Hostel Desk / Mess Desk at PDPU Campus.

Hostel facility is available on PDPU Campus. For the first year M. Tech. Candidates enrolled in 2016-17, hostel facilities will be provided on first come first basis, subject to availability.

To secure the Hostel facilities, following fees are required to be paid for the academic year 2016-17. These fees are subject to revision from time to time.

Annual Hostel Fees (Non Refundable): ` 63,000/-

Hostel Deposit (Refundable): ` 5,000/-

Electricity charges would be levied (calculated) on actual consumption basis.

Mess Charges are as follows for academic year 2016-17. (Subject to revision from time to time)

Mess Bill of ` 37,500/- per year for lunch, dinner and snacks as per canteen schedule. This is compulsory for candidate opting for PDPU Hostel Facility.

Mess Bill of ` 25,000/- per year for lunch and snacks as per the canteen schedule. The above mentioned Hostel Fees / Mess Charges have to be paid through a Demand Draft drawn in favor of 'Pandit Deendayal Petroleum University', payable at Ahmedabad.

7. Cancellation of Admission and Refund of Fees:

(A) Cancellation of admission by the University:

- In case the candidate fails to produce original documents within the specified time period only deposits (Rs.13,000/-) shall be refundable.
- During verification of documents or subsequently, if the University finds any certificate or testimonial or information submitted by any candidate is incorrect or false, the candidature of such candidate shall be cancelled for that year. For such candidates only deposits (Rs.13,000/-) shall be refundable.
- If the University is satisfied that a certain candidate on no fault of his has been wrongly admitted, fees & deposits paid if any, for the ongoing semester shall be refundable.

(B) Cancellation of admission by the candidate:

The fees for all candidates will be refundable after deducting Rs. 1,000/- as admission processing fees, irrespective of when they cancel. However this is applicable only if at least 20 (for Chemical) and 15 (for Nuclear/ Energy Systems & Tech.) seats in respective branch are filled up by the completion of admission process as announced in the policy.

If the seat remains vacant due to cancellation of admission, Rs. 13,000/- shall be refundable.

The said fee refund shall be made on 8th September, 2016.

The candidate shall be required to **submit the original receipt** of the fees paid for refund in the prescribed form. The application for cancellation is to be submitted to:

8. Financial Assistance:

The University has decided to offer from its own resources a fellowship of Rs. 12,400/- p. m. to all candidates admitted, provided they are having Qualified & Valid GATE score. As a part of this fellowship which will be effective from the start of the semester, such candidates shall have to perform mandatorily the duties as Teaching Assistant. No additional compensation/financial assistance in this regard shall be permissible. Continuance of the financial assistance i.e. the fellowship from semester to semester shall subject to the discipline, punctuality and good academic performance as mentioned hereunder:

To become eligible for the continuance of the fellowship in subsequent semesters, the students are required 1. To have earned Minimum CPI of 6.5 in every semesters. 2. To have passed every semester examinations at the first attempt besides regular attendance, disciplined and exemplary behavior and compliance with all other norms, as prescribed by the University from time to time. Continuance of the financial assistance from semester to semester shall subject to the discipline, punctuality and good academic performance as laid down in the rules besides the availability of fund with the University. Such students must not be getting any kind of financial assistance/support e.g. fellowship/scholarship/fee waiver etc. from any other source.

9. Warning Against Ragging:

Ragging is completely banned in PDPU. As directed by the UGC also under the instructions of the Supreme Court, students are prohibited from indulging into any kind of ragging inside and outside the University campus. The Anti-Ragging Committee of the University is authorized to take very strict actions against the students indulging into Ragging; including expulsion from the University. The students shall have to submit an undertaking in the prescribed proforma along

with the signature of their parent/guardian to the effect that they are aware of the severity of the offences related to the Ragging.
