2. Eligibility Criteria

Minimum 60% or CPI/CGPA of 6.5 in 10 point scale in the qualifying degree (recognized by the UGC/AICTE) as mentioned hereunder for admission in the M. Tech. program:

M. Tech. (Petroleum Engineering - Part time)

B. E. / B. Tech. in Petroleum Engineering / Hydrocarbon Refinery Engineering / Petrochemical Engineering / Mechanical Engineering / Chemical Engineering.

Candidate must have minimum 3 years of Oil and Gas Industry experience, post acquiring the above referred UG qualification. Candidate should be on the regular/permanent Job.

Application fee of Rs.700/- (Non Refundable) is to be paid as a part of the online application process.

3. Admission Process

A single merit list will be prepared for valid and qualified GATE and Non-GATE candidates on following basis:

- i. Performance score obtained in Personal Interview by the candidate.
- ii. 50% weightage of GATE score (applicable to GATE qualified candidates).

The valid proof of employment is to be submitted at the time of personal Interview.

If candidate is selected, admission will be confirmed on submission of No-Objection certificate from the employer in the prescribed form as per the Annex. – I.

4. Fee Structure

The candidates offered the admission shall have to pay the fees as shown hereunder:

5. Admission Intake: 18 seats

No financial assistance will be given to candidates admitted in the Part Time program.

6. Cancellation of Admission and Refund of Fees

A. Cancellation of admission by the University:

- i. In case, a candidate fails to produce original documents within the specified time period, his/her admission shall stand cancelled; and only deposits (Rs.13,000/-) shall be refunded.
- ii. During verification of documents or subsequently, at any point of time, if the University finds any certificate or testimonial or information submitted by any candidate is incorrect or false, or in non-conformity with the eligibility criteria or any other requirement, the candidature of such candidate shall be cancelled. For such candidates, only deposits shall be refunded.
- iii. If the University is satisfied that a certain candidate on no fault of his own has been wrongly admitted, fees & deposits paid if any, for the ongoing semester shall be refunded.

B. Cancellation of admission by the candidate:

If a candidate applies for cancellation of his/her admission through email/in-person, the fees paid shall be refunded after deduction of Rs.1000/- as administrative charges, only if such vacated seat gets filled up latest by the start of the semester.

The refund will be made on or after 15th October 2021 only after receiving all required documents from the candidate in this regard.

The candidate shall be required to submit the original receipt of the fees paid for refund in the prescribed form. The application for cancellation is to be submitted to –

7. Warning against Ragging
